Detailed Notification for Recruitment for the Post of Centre Head-CoEET on Fixed Term Basis

About the Centre of Excellence for Energy Transition (CoEET)

Eastern Power Distribution Company Limited of Andhra Pradesh Limited (APEPDCL) developed Andhra Pradesh's first state-of-the-art Super ECBC building at Sagar Nagar, Visakhapatnam, with an investment of Rs.13.5 crores, including a Rs.5 crore grant from the Bureau of Energy Efficiency. During the APPCC meeting held on 5th July 2025, it was approved to convert this building into a Centre of Excellence for Energy Transition (CoEET) under a collaborative model and it was also agreed that future expenditures for CoEET would be shared among AP DISCOMS, APGENCO, and APTRANSCO.

APEPDCL has since initiated the establishment of CoEET, envisioned as a registered Trust or Society, serving as a collaborative platform for innovation, skill development, entrepreneurship and policy support in the clean energy domain. The centre's vision is to become a leading hub for sustainable energy transition. Its objectives include fostering research, capacity building, multi-stake holder collaboration, policy support, and startup incubation. CoEET has been registered as a society [Reg. Number: 618 of 2025] under the societies act. Over the next five years, CoEET aims to deliver more than 20 applied research and pilot projects, train over 1,000 professionals, incubate 10+startups and contribute meaningfully to policy development.

To effectively progress towards achieving the objectives of Centre of Excellence for Energy Transition, applications are invited from experienced, dynamic and motivated individuals having relevant experience for the recruitment for the post of Centre Head- CoEET on Fixed Term Basis as per the details mentioned below:

Job Description

The Centre Head–CoEET will provide visionary support to Centre of Excellence for Energy Transition, steering its strategic, operational, and financial growth into a leading innovation hub of national and global significance in the field of power sector. The person will oversee daily operations, guide incubation and acceleration programs, forge partnerships, and mobilize funding to build and sustain a thriving start up ecosystem in Andhra Pradesh.

Key Responsibilities

- Lead all operations of CoEET, providing strategic direction and scaling incubation and acceleration programs.
- Build collaborations with government agencies, corporates, funding institutions, and ecosystem partners to ensure sustained growth and relevance.
- Guide and oversee functions related to incubation management, financial management, infrastructure, and outreach.
- Represent CoEET with internal and external stakeholders, including institutional bodies, funding agencies, investors, and industry anchors.

- Represent CoEET in national and international forums to enhance visibility, credibility, and strategic positioning.
- Enable startups to access funding and strategic partnerships by building strong networks with government programs, angel investors, venture capitalists, corporates, and domain experts.
- Ensure preparation of all required documentation, including operational reports and progress evaluation reports for submission to relevant agencies.
- Design and implement sustainability strategies, supporting startups from early to growth stages while ensuring CoEET's operational and financial health.
- Foster collaboration with academic institutions, technology research organizations, and ecosystem stakeholders for capacity building programs and knowledge exchange.
- Plan, launch, and manage incubation programs in energy sector.
- Identify and support high-potential startups by connecting them to mentors, investors, and industry experts.
- Monitor and track the growth of incubated startups using structured metrics and regular review mechanisms.
- Facilitate knowledge-sharing initiatives, capacity-building workshops, and networking events.
- Collaborate with government agencies to unlock policy benefits and support for startups.
- Design and execute innovation challenges, themed cohorts, and joint initiatives with industry and academic partners.
- Regularly engage with stakeholders to identify evolving industry needs and align partnership strategies accordingly.

General Conditions

1. Only Indian Nationals are eligible to apply.
2. All qualifications should be from Universities/ Institutions recognized and approved in India or abroad.
3. All computations of age, experience requirement, qualification, etc. shall be done w.r.t. the last date of receipt of online application as mentioned in the advertisement.
4. Depending on the requirement, the management reserves the right to cancel/ restrict/ curtail/ increase the number of vacancies, if need arises, without any further notice and without assigning any reason thereof.
